#### I. ITEMS FOR DISCUSSION

1. 2021-514 ACT-Grant Agrmnt & IMAs-Sexual Risk Avoidance Education Prgm.

AN ACT authorizing the County of Westchester to enter into (i) a grant agreement with the New York State Office of Children and Family Services to accept grant funds to continue a Sexual Risk Avoidance Education Program and (ii) to enter into inter-municipal agreements with the Cities of Mount Vernon, New Rochelle, Ossining, Peekskill, Port Chester, White Plains and Yonkers for services to be funded with the grant funds.

Dr. Harris-Madden explained that this request grants permission to enter into an Inter-Municipal Agreement with the New York State Office of Children and Family Services (OCFS) to accept grant funding for the Sexual Risk Avoidance Education Program, currently serving Mount Vernon, New Rochelle, Ossining, Peekskill, Port Chester, White Plains and

Yonkers. Through trainings and opportunities, this program intends to delay the onset of sexual activity by becoming involved in positive youth development activities and programming, such as health relationship workshops, career awareness and leadership programming. They provide programming through the Youth Bureaus in addition to collaborating with the Nepperhan Community Center and the One Love Foundation. They provide paid employment, internships and job shadowing opportunities. They also provide the Ready Attributes curriculum, which helps them develop soft skills while focusing on graduating as their ultimate goal. Last year they served 135 youths and received positive feedback from most of them, part of the impact was due to COVID as it affected the timeline of the project. The program is evidence based and scientifically accurate, ensuring that young men and women are properly educated. This year the focus is more workforce development and healthy relationship focused. Since the funding for this program is not limiting in terms of reach, they are trying to expand to other municipalities such as Mount Kisco by way of the Boys and Girls Club of Northern Westchester, and other organizations. Each organization receives approximately \$30,000 for programming, staff and training. They are continuing to apply for additional funding to grow this program and the opportunities that it provides to the youth.
