*Mr. Soule said that this act will extend the County's authority to impose an additional 1% sales tax from December 1, 2023 to November 30, 2025. The original increase from 3% to 4% was authorized in August 2019, and will expire on November 30, 2023.*

*Chairman Gashi emphasized that this is an extension of the current sales tax rate, not an additional 1%.*
