Hello. My name is Elio Giuliani.

I was born in Yonkers, NY, am a proud graduate of the Yonkers Public Schools, 1971, and Manhattan College, class of 1975 in Accounting.

I have been an owner and have lived at my apartment in West Harrison, NY for over 30 years. I am married and my smart wife and I live in the traditional section of West Harrison near the Mintzer Community Center, Passidomo Park and pool center, the West Harrison Public Library, St Anthony's church and the Preston elementary school.

I am now retired for nearly 3 years but I have over 40 years experience of managing contracts, analyzing expenses and bills, paying monthly billings for contracts and dealing with issues from my work in 6 major departments in Westchester County government as an accountant and fiscal manager in various titles as I advanced. My degree is in Accounting but I have performed a variety of important duties besides the fiscal and budgetary responsibilities of accounting. Some are discussed below.

Negotiation Team we obtained contract settlements for 4,000 families which were overwhelmingly approved by the voting membership in the union and ratified by the County Board of Legislators.

As a senior at this time, but still very active, I would greatly enjoy being part of the Westchester County government activities in being an advocate for our worthy senior citizens and would be honored to be part of the Council for Seniors if so chosen. Being active after retirement is one aspect of my life that is most rewarding.


