Mr. Delborgo explained the use of the facility as our emergency operations center which is the central clearinghouse for coordination for the County's response to major emergencies. The County shares the building with several New York State agencies. The County has occupied it since 2004. The facility has a lot of audio and visual capability as well as the capacity for 100 responders.

Ms. Noe added that in addition to it being the emergency operations center, it is a backup for the dispatch center on Dana Rd and is a backup data center to the data center in White Plains. There is no rent charged for the space but there is a shared expense for the utilities and operations which is at 19%.

Legislator Boykin asked if we are doing anything to upgrade the technology and our ability to communicate throughout the County. Mr. Delborgo said yes and made reference to Capital Project BES 19 which will kickoff the first project of 2025 that will begin the upgrades on the facility to not only include technology but carpet, furniture and more.
