# MINUTES APPROVAL

# I. ITEMS FOR DISCUSSION

## 1. <u>2025-21</u> <u>PH-Battery Energy Storage Systems</u>

Guests: Law Dept.: Assistant Chief Deputy County Attorney Justin Adin and Assistant County Attorney Alida Marcos; DES: Commissioner Susan Spear, Douglas Stiller, Chief, DES Special Operations, and Chris Johnson, Deputy Chief, DES Special Operations; New Rochelle Fire Chief Andrew J. Sandor, Chair, Westchester County Fire Advisory Board

Commissioner Spear explained that this legislation is similar to state legislation regarding hazardous materials, which requires that fire departments and the County be notified of hazardous materials on a site. She noted that the definitions in the state law do not include

materials from battery energy storage systems. She said that if these facilities catch fire, it can get very hot very quickly and even become explosive. These fires also emit hazardous gases, so it is essential that firefighters, EMS and other first responders know what is on site when they arrive at an incident for everyone's safety.

Legislator Barr asked if the County will be sending something to communities to advise on where battery energy storage system facilities should and should not be placed. Mr. Johnson said that is a decision by the municipality and the state, and depends upon the size of the facility.

3. <u>2025-23</u> <u>PH-Tax Exemption for Volunteer Firefighters and Volunteer</u> <u>Ambulance Services Members</u>

*Mr.* Adin explained that the current County law provides a property tax exemption for volunteer firefighters and volunteer ambulance services members that serve in the same municipality where they live. He said that the State amended its law to allow local jurisdictions to expand the tax exemption where the property owner serves in a neighboring municipality, so this legislation will provide that a property owner who lives in the County and volunteers anywhere within the County can get the exemption.

Chairman Gashi asked whether the exemption applies to other volunteer entities such as volunteer sheriffs. Mr. Adin said that the state controls what exemptions the County can allow,

and they would need to pass legislation to expand those who qualify beyond volunteer firefighters and volunteer ambulance services members.

Legislator Nolan questioned why the FIS states that there will be no fiscal impact from this legislation. Ms. Rampata said that the County still collects the same amount of taxes, it just gets distributed differently among the property owners in the municipality.

Legislator Pierce said that she is grateful for the expansion provided by this legislation because it will help improve recruitment and retention of the volunteer fire and ambulance services.
