## MINUTES APPROVAL

## I. ITEMS FOR DISCUSSION

1. <u>ACT-2023-173</u> <u>ACT - Lawsuit Settlement of Sydnor v. County of Westchester</u>

AN ACT authorizing the County Attorney to settle the lawsuit entitled Sydnor v. County of Westchester in the amount of SIX HUNDRED TWENTY-FIVE THOUSAND (\$625,000) DOLLARS.

*Mr.* Gardner said that there is a tentative settlement of \$625,000 for this case, inclusive of the \$250,000 self-insured retention in the County's insurance policy. He explained that the case arose from an accident on March 3, 2015, in which the plaintiff was stopped at a red light on Nepperhan Avenue at the intersection with Lake Avenue in Yonkers when it was rear-ended by a Liberty Lines bus. The plaintiff underwent numerous medical procedures, including many spinal injections and two fusions.

*Mr.* Gardner said that the settlement takes into consideration the uncertainty of litigation and the potential costs of trial, subsequent proceedings and potential appeal, and both outside counsel and the County's insurer's adjuster recommend this settlement.

*Mr.* Vetrone said that this project will fund the replacement of major electrical distribution equipment at the Peekskill Water Resource Recovery Facility. The current bonding request, in the amount of \$200,000, would fund a study to evaluate and document deficiencies for all equipment and replacement options. The report will focus on, but not be limited to, switchgears, motor control centers, power panels, and main feed distribution systems plantwide.

A BOND ACT authorizing the issuance of ONE MILLION (\$1,000,000) DOLLARS in bonds of Westchester County to finance Capital Project SNR23 - New Rochelle Water Resource Recovery Facility (WRRF) Sludge Thickener Rehabilitation.

This work will include repair or replacement of all mechanical, plumbing, HV AC, odor control, instrumentation, electrical, structural and architectural systems, including all necessary appurtenances. The sludge thickener

tank equipment and roofing are reaching the end of their useful life and need to be replaced. The new equipment will improve the operational performance, reliability, and efficiency of the facility. The Department is required to keep its water and wastewater treatment facilities in a state of good repair, in accordance with State and Federal regulations.

*Mr.* Vetrone said that this Bond Act, in the amount of \$3,000,000.00 would finance the design, construction management and construction costs for the rehabilitation of the ultraviolet light disinfection system at the New Rochelle Water Resource Recovery Facility, which includes the replacement of or improvements to all mechanical, plumbing, HV AC, odor control, instrumentation, electrical, structural, and architectural systems, including all necessary appurtenances. The existing equipment has a high operation and maintenance cost that could potentially be lowered by making improvements to the equipment.

Chief Information Officer Beirne and Mr. Prakash discussed the item. They advised that the proposed Capital Budget Amendment will amend the County's current-year capital budget to increase the County share for BIT50 by \$2,535,000. The current request will fund the additional functions to be added to this system, including but not limited to: time and leave management, overtime, personnel transactions forms, and automated W2 and 1099 processing in addition to a Help Desk supported by CGI personnel for Department users, for a period of three months, and additional training for end users. The Bond Act, in the amount of \$2,535,000, would finance the additional cost of software and implementation services for DoIT. AMS/ CGI, the vendor for the County's Financial, Human Resource and Budget systems, informed the County that it is instituting a major systems renovation and will no longer support existing systems. BITS0 will fund the cost of the implementation services and related expenses for AMS/CGI to upgrade the County's systems to the new version and the purchase of data processing equipment and database software.
