

**Founder**



Shirley Acevedo Buontempo is the Founder of Latino U College Access (LUCA), where she has built a successful organization that brings together cultural relevance, bilingualism, and program strategy to provide college access and opportunity to first-generation Latino youth. Born in Puerto Rico and a first-gen college graduate herself, she is passionate about advocating for the needs of low-income Latino youth and ensuring they can make their college dreams a reality. Founded in 2012, under Shirley's leadership, Latino U College Access has grown from a pilot program in one local high school with 2 Latino U Scholars to a recognized leader in the field of college access and success with annual revenue of over \$1.3MM. Her vision has expanded the organization's services to reach over 6,000 Latino parents and students and coached over 300 Latino U Scholars annually to successfully apply, enroll and graduate from college. Shirley currently serves on the organization's Board of Directors where she is instrumental in supporting strategic planning initiatives and future growth.

Shirley has quickly established herself as a thought leader and advocate for Latino youth addressing educational inequity and ensuring equal opportunity and access for all. She serves on advisory boards of the Hispanic Federation, National College Attainment Network, and the Options Institute sharing insight, and resources on improving access to higher education among underserved communities. She also serves on the Advisory Board of the YWCA Westchester Center for Racial Equity and Westchester Women's Agenda Racial Equity Group.

Shirley was one of five national winners selected as a Fellow to receive the 2019 AARP Purpose Prize in recognition of her efforts to build and launch a nonprofit organization utilizing her life experience to "create new solutions that make the world a better place for people of all ages." The organization's programs were also recognized as an Example of Excelencia by Excelencia in Education, a national advocacy and research group that brings attention to evidence-based practices that accelerate Latino student success in higher education. Shirley has been featured in Time Magazine's American Voices Video Series, Fortune Magazine, Hispanic Executive Magazine, and the ABC and Univision networks for her work and leadership in launching Latino U College Access.

Before founding Latino U College Access, Shirley had a successful career in Hispanic Marketing and Advertising having worked for Grey Advertising, Saatchi and Saatchi and CPC International. Her nonprofit management career included work at local organizations serving the Latino community of Westchester County. She received both a BBA in Marketing and an MPA in Nonprofit Management from Pace University. Shirley was a 2014 Fellow in the National Hispana Leadership Institute and has received certification from the Harvard University Kennedy School of Executive Leadership and the Center for Creative Leadership.

**EXECUTIVE ORDER NO. 1 OF 2022**

**WHEREAS, Over the past decade, local governments across the United States have increasingly become targets of cybercriminals, victims of ransomware attacks and are under constant or nearly constant cyberattack from many directions; and**

**WHEREAS, cybersecurity threats are constantly evolving to become more sophisticated and threatening; and**

**WHEREAS, cyberattacks have already hit New York state agencies, 911 systems, cities, towns and school districts and pose a significant risk to water systems, utilities, airports, schools and health care facilities, and cyberattack complaints increased from 114,702 in 2019 to 241,342 in 2020, according to the FBI; and**

**WHEREAS, recent cybersecurity incidents such as SolarWinds, Microsoft Exchange, and the Colonial Pipeline are a sobering reminder that U.S. public and private sector entities increasingly face sophisticated malicious cyber activity from both nation-state actors and cyber criminals; and**

**WHEREAS, in the United States, two well-publicized cases of local government breaches—Atlanta, Georgia, in 2018, and Baltimore, Maryland, in 2019—cost those cities \$15 million and \$18 million, respectively; and**

**WHEREAS, data breaches result in the expense of discovering and responding to the breach, the cost of downtime, and lost revenue, and the long-term reputational damage to an organization and its brand; and**

**WHEREAS, cybersecurity breaches could harm individuals whose personally identifiable information in the County's possession is improperly accessed by hackers; and**

**WHEREAS, a strong cybersecurity strategy to protect critical systems can provide a good security posture against malicious attacks designed to access, alter, delete, destroy or extort an organization's or user's systems and sensitive data, and prevent attacks that aim to disable or disrupt a system's or device's operations; and**

**WHEREAS, it is crucial that Westchester County implement steps to anticipate and prepare for cybersecurity threats because failure to do so places the County at increased risk of suffering otherwise preventable cybersecurity breaches;**

**NOW, THEREFORE, I, George Latimer, County Executive of the County of Westchester, in accordance with my statutory duties, do hereby order that there shall be a Task Force on Cybersecurity (“Task Force”) to advise the County Executive and the Board of Legislators; and it is further**

**RESOLVED that the Task Force shall be constituted as follows:**

- 1. The Task Force shall consist of nine (9) members;
  - a. The Board of Legislators shall appoint three members of the Task Force;**
  - b. The County Executive shall appoint six (6) members;****
- 2. Of the nine (9) members first appointed, three shall be appointed until December 31, 2022; three (3) shall be appointed until December 31, 2023; and three (3) shall be appointed until December 31, 2024; Thereafter each member of the Task Force shall be appointed to a three (3) year term;**
- 3. The County Executive shall designate the Chair of the Task Force;**
- 4. The Chief Information Officer or her designee shall serve as an ex officio member of the Task Force. Other ex officio members may be designated by the County Executive as deemed necessary;**
- 5. The Chair of the Board of Legislators shall designate one of the members of the Board of Legislators to serve as an ex officio member of the Task Force;**
- 6. The members of the Task Force shall be residents of Westchester County;**
- 7. The members of the Task Force shall serve without compensation;**
- 8. The Task Force shall meet at such times and places as the members determine;**
- 9. The Task Force shall review the County’s current cybersecurity policies, procedures, practices and programs to assess the County’s overall cybersecurity risks including the County’s susceptibility to ransomware attacks;**

10. The Task Force shall recommend effective policies and/or services, strategies, legislation and funding priorities to reduce the threat of cyberattacks, ensure the implementation of procedures for the identification and response to cyberattacks, and that appropriate training for all County employees on cybersecurity is instituted Countywide; and it is further

**RESOLVED**, that this Executive Order shall take effect immediately and shall remain in effect until otherwise superseded or revoked.
