RESOLUTION NO.117-2024

BY COUNCIL PRESIDENT COLLINS-BELLAMY, MAJORITY LEADER RUBBO, MAJORITY WHIP ROBINSON, MINORITY LEADER BREEN, COUNCILMEMBERS, PINEDA –ISAAC, DIAZ AND MERANTE:

RESOLUTION DIRECTING THE REFERRAL OF THE PROPOSED GENERAL ORDINANCE INSTITUTING AN EIGHT-MONTH MORATORIUM ON SELF-STORAGE FACILITIES WITHIN THE CITY OF YONKERS AND SETTING A PUBLIC HEARING.

WHEREAS, the City has proposed a temporary moratorium on selfstorage units whereby no approval for, permitting, or construction of new units may be granted by the City, including, but not limited to, the approval of any of a zone change, variance, subdivision, site plan, special use permit, building permit, demolition permit, or sign permit; and

WHEREAS, the City Council finds that the necessary, temporary action proposed by this ordinance, consisting of deliberative information collection as part of the continuing administration and management of the City, constitutes a Type II action under the New York State Environmental Quality Review Act and therefore requires no further environmental review; and

WHEREAS, Section 239-m of New York General Municipal Law requires referral of any proposed land use moratoriums to the Westchester County Planning Board;

WHEREAS, Section 43-164 of the Zoning Ordinance requires referral of all amendments to the Zoning Ordinance to be considered by the City Council to the Yonkers Planning Board for its review and report;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Yonkers that a public hearing shall be held on June 26, 2024, at the City Council Chamber, located at 40 South Broadway, New York, at 5:45 PM, or as soon as possible thereafter, to consider the adoption of a general ordinance establishing a temporary moratorium on self-storage units within the City of Yonkers pending appropriate review; and

BE IT FURTHER RESOLVED, that in accordance with Section 43-164 of the Zoning Ordinance and Section 239-m of NY General Municipal Law, the City Council hereby refers the proposed establishing a temporary moratorium on self-storage units within the City of Yonkers pending appropriate review to the Yonkers Planning Board and Westchester County Planning Board for their review and report; and be it further;

RESOLVED, that this resolution shall take effect immediately.
