PH - The Senior Citizens and Persons with Disabilities Home Owner's Tax Exemption

A Public Hearing on A LOCAL LAW amending Chapters 470 and 472 of the Laws of Westchester County to allow senior citizens and persons with disabilities to reduce their income by the amount of unreimbursed medical and prescription drug expenses in order to qualify for tax exemptions and to increase the maximum eligible income. Ms. Macleod explained that this is an amendment to existing sections of the Laws of Westchester County. The Laws of Westchester County provide for real property tax exemptions for seniors and persons with disabilities. In order to get this exemption there is a certain threshold of income that individuals need to meet. This was done under the laws of Westchester County. These exemptions were granted in the New York State Real Property Tax Law. On August 8, 2022, New York State amended the threshold that you need to have in order to receive the exemption. This has not been updated in a period of 12 to 13 years. The State of New York has increased the maximum eligible income to \$50,000.00. The maximum amount for the full exemption, and that a reduced exemption is permitted on a sliding income scale up to a maximum income of \$58,399.99.

Ms. Macleod stated that Westchester County is entitled to exclude certain monies from the income calculation. Pursuant to State Law, the County can exclude unreimbursed medical and prescription drug expenses incurred by applicants from their calculated income.

Legislator Alvarado asked, how are we paying for this? Mr. Soule replied that it has no fiscal impact on the County budget because we submit our tax warrants to the municipalities who collect our taxes on our behalf and they pay one hundred percent.
