HONORABLE BOARD OF LEGISLATORS THE COUNTY OF WESTCHESTER

Your Committee is in receipt of a communication from the County Executive recommending the adoption of an Act which, if adopted by your Honorable Board, would authorize the County of Westchester (the "County") to adopt a new 'Multi-Jurisdictional, Multi-Hazard Mitigation Plan' for the County, which is known as the Westchester County Hazard Mitigation Plan, (the "New Plan") with annexed plans for participating municipalities. Your Committee has been advised that a complete copy of the New Plan is on file and available for inspection in the office of the Clerk of your Honorable Board.

Your Committee has been advised that, in accordance with regulations of the Federal Emergency Management Agency ("FEMA") in 44 C.F.R. §201.6(a)(1), a "local government must have a mitigation plan approved...in order to receive [Hazard Mitigation Grant Program] project grants" and "in order to apply for and receive mitigation project grants under all other mitigation grant programs."

Your Committee has been advised that your Honorable Board authorized the County to adopt the existing 'Multi-Jurisdictional, Multi-Hazard Mitigation Plan' (the "Existing Plan") in 2016, by Act 2016-208.

However, your Committee has been advised that FEMA requires that such plans be maintained on a five-year cycle, as 44 C.F.R. §201.6(d)(3) specifies that a "local jurisdiction must review and revise its plan to reflect changes in development, progress in local mitigation

efforts, and changes in priorities, and resubmit it for approval within 5 years in order to continue to be eligible for mitigation project grant funding."

Your Committee has been advised that, therefore, the County issued a request for proposals for consulting services regarding the development and preparation of an update to the Existing Plan. Your Committee has been advised that this competitive procurement resulted in the County contracting with Tetra Tech, Inc. (the "Consultant"), which has the necessary expertise in this area.

Your Committee has been advised that the County, the Consultant, and the participating municipalities prepared and updated county-wide provisions as well as municipality-specific plans, which are in "annexes" that are attached to the New Plan, for those municipalities that desired to participate in the plan process. Your Committee has been advised that, during the course of the work on the New Plan, the County, local leaders, and the community worked in tandem to identify risks, assess capabilities, and formulate a strategy to reduce disaster vulnerability.

Your Committee has been advised that the New Plan that was finalized and is being presented to your Honorable Board is a revised version of the Existing Plan, with modifications made in light of changes and updates that have become necessary over the past approximately five years. Your Committee has been advised that your Honorable Board is only being asked to approve of the New Plan, consisting of the county-wide provisions and the County's own specific annex. Your Committee has been advised that all other municipality-specific annexes

will be subject to review and approval by each such municipality's own governing body.

Your Committee has been advised that all jurisdictions within Westchester County have exposure to natural, technological, and human-caused hazards that increase the risk to life, property, environment, and the county and local economy. Your Committee has been advised that proactive mitigation planning for known hazards before a disaster event occurs can reduce or eliminate long-term risks. Your Committee has been advised that the purpose of the New Plan is to demonstrate commitment to reducing risks from multiple hazards, and to serve as a guide for decision-makers as they commit resources to reduce the effects of natural, technological, and human-caused hazards. Your Committee has been advised that the New Plan can also serve as the basis for New York State and the Federal government to provide technical assistance and prioritize project funding. Your Committee has been advised that, in addition, the New Plan will ensure that the County remains on the five-year cycle required by FEMA, and will consequently enable the County, and its participating municipalities that have approved of their own annexes, to remain eligible for certain grants, as noted above.

Your Committee has been advised that the New Plan is compliant with the applicable requirements of 42 U.S.C. §5121 et seq., 44 C.F.R. Part 201, and other applicable New York State and Federal requirements, as determined by FEMA and the New York State Division of Homeland Security and Emergency Services ("NYSDHSES"), which include, but are not necessarily limited to, FEMA's "Local Mitigation Plan Review Guide" and "Local Mitigation Planning Handbook" and NYSDHSES's "Hazard Mitigation Planning Standards" guide.

Your Committee has been advised the New Plan has been approved by NYSDHSES and forwarded to FEMA with a request that FEMA approve of it, pending adoption of the New Plan by your Honorable Board.

Your Committee has been advised that the Planning Department has advised that, based on its review, the proposed action would constitute an "Unlisted action" under 6 NYCRR Part 617, which are the implementing regulations for Article 8 of the Environmental Conservation Law, commonly known as the State Environmental Quality Review Act ("SEQRA"). Your Committee has been advised that, accordingly, the Planning Department has prepared the attached Short Environmental Assessment Form to assist your Honorable Board in making the required determination of significance. As you know, your Honorable Board may utilize the professional advice and assistance of the Planning Department in making your required determination of significance. Your Committee has been advised that, should your Honorable Board conclude that the proposed action will not have any significant adverse impact on the environment, it must adopt the attached resolution (the "Resolution") issuing a "Negative Declaration" prior to adopting the attached proposed Act.

Your Committee has been advised that the adoption of the proposed Resolution and Act requires an affirmative vote of a majority of the members of your Honorable Board.

After due consideration, your Committee recommends adoption of the proposed Resolution and Act.

ACT NO. 2022 - 6

BE IT ENACTED by the County Board of the County of Westchester as follows:

Section 1. The County of Westchester (the "County") hereby adopts the multijurisdictional, multi-hazard mitigation plan known as the Westchester County Hazard Mitigation Plan (the "New Plan"), a complete copy of which is on file and available for inspection in the office of the Clerk of the County Board of Legislators, and resolves to execute the actions identified in the New Plan that pertain to the County.

- §2. The County will use the adopted New Plan to guide pre- and post-disaster mitigation of the hazards identified.
- §3. The County will coordinate the strategies identified in the New Plan with other planning programs and mechanisms under the County's authority.
- §4. The County will continue its support of the Mitigation Planning Committee as described within the New Plan.
- §5. The County will help to promote and support the mitigation successes of all participants in this New Plan.
- §6. The County will incorporate mitigation planning as an integral component of government and partner operations.
 - §7. The County will provide an update of the New Plan no less than every five years.
- §8. The County Executive or his authorized designee is hereby authorized to execute all instruments and take all actions reasonably necessary to carry out the purposes of this Act.
 - §9. This Act shall take effect immediately.
