1. 2023-252 ACT - Authorizing a Settlement in the Redistricting Lawsuit

County Attorney John Nonna, Deputy County Attorney Justin Adin, and Senior Assistant County Attorney Shawna MacLeod appeared before the committees to discuss the item. Mr.

Adin said that the settlement agreement is a fairly standard in that: 1) there is no admission of wrongdoing; 2) there are mutual releases on all sides; 3) it is contingent upon the enactment of the amendments to the redistricting; which will be done by the accompanying local law; and 4) it disposes of the proceeding with the exception of a discrete item in the cross-petition, which relates to whether the County is responsible for a payment of outside counsel fees for Legislators Cunzio and Nolan in this action.

Mr. Bass said that the Board of Legislators and the County Executive's office included the authorization of installation of red light cameras for the County in the joint state legislative package, which was adopted unanimously. The State legislature is moving forward, and has amended the bill that was before them. The Board previously passed a Home Rule Resolution a few weeks ago, but a new resolution is needed because there was an amendment to the

legislation.

Chair Smith asked what the amendments were. Mr. Bass said that we have an 80/20 share with our local municipalities, and the new amendment provides that we will share that 20% with our cities, which were previously excluded from the bill.
