RESO-Clean Slate Act RES-2022-11

A RESOLUTION in support of the Clean Slate Act in relation to the automatic sealing of certain convictions in New York State.

Submitted by COMMITTEE ON LEGISLATION

Chair Smith spoke about the resolution and discussed several changes that needed to be made, with the Committee debating the distinction and possible legislative intent behind the language used. Legislator Cunzio raised a concern about the evaluation of cases, with Chair Smith speaking on the exemptions and caveats in the proposed state legislation. Legislator Johnson elaborated on this and spoke about the importance of this legislation with Legislators Maher and Borgia concurring and speaking about the numerous benefits this legislation would bring. Legislator Nolan raised a number of concerns and spoke as to why his own personal experiences would not allow him to support the legislation. Legislator Borgia addressed the concerns of Legislator Nolan and said that the intent is allowing people who have served their time to reintegrate and reduce the risk of recidivism. Legislator Johnson also clarified that the records would still be available to the criminal justice system, with Legislator Williams-Johnson and Pierce pointing out that this wasn't an expungement, and if someone was rearrested all of that information would be available to the courts. Legislator Barr concurred with the previous sentiments but pointed out that they run into these issues sometimes when writing resolutions of support. Legislator Nolan asked if the Department of Public Safety would be able to be brought in for this, to which Chair Smith stated that for the purposes of this resolution it wasn't necessary. Legislator Johnson pointed out additional language that needed to be amended and the revisions were made.

On motion of Legislator Johnson, seconded by Legislator Maher, the above item was signed by committee to the Board of Legislators committee, due back on 2/7/2022. The motion carried by the following vote:
