Commissioner Kopicki and Mr. Brown discussed the item. Chair Pierce asked how the total of \$41.5 million was reached. Commissioner Kopicki said that they were currently asking for \$21 million in addition to the \$20.5 million originally appropriated. She noted that Commissioner Kopicki said that they paid \$6 million for the first tank, and there are 5 tanks left, for a total of \$36 million, which doesn't match what's in the documentation. Commissioner Kopicki said he would have to double check, but this may have been based on a first estimate with a cushion built in, and because this type of work is so expensive, a \$5.5 million cushion is not unreasonable. Chair Pierce asked him to send the cost breakdown and an explanation of the discrepancy.
