#### **MINUTES APPROVAL**

On motion of Legislator Gashi, seconded by Legislator Pierce, the minutes were approved. The motion carried unanimously.

#### I. ITEMS FOR DISCUSSION

ACT-2023-96 ACT - Settlement of Workers Comp Lien (D.O.)

AN ACT authorizing the County of Westchester to compromise its right to be reimbursed for health care and wage benefits paid to or on behalf of a County employee from a settlement of her legal action against a third party tortfeasor.

Senior Assistant County Attorney Sean Carey appeared before the Committee to discuss the

item. Mr. Carey explained that there are two types of workers compensation cases that the County regularly sees. First is a case in which the County has a lien on the proceeds of a third part settlement, and the second is a matter where there is a lump sum settlement to offset future expenses that the County will owe to the employee. Mr. Carey discussed that this item is essentially the same principle as the second item with more money at stake and with the additional wrinkle that the inciting incident was a pedestrian knocked down. Mr. Carey explained that pursuant to statutory law, this is considered a motor vehicle accident. The employee received significant injuries when they were struck by an independent contractor working for the City of White Plains and was out of work for 35 weeks and 6 days. The employee agreed in principal to settle her personal injury claim for \$1.2 million dollars pending the consent of the County. In connection with the proposed settlement, the council notified this office that his costs, disbursements, and legal fees totaled \$418,945.56. The expenses that the County incurred with regard to the Workers Comp Claim between the date of the accident and the date of the proposed settlement are in the amount of \$89,026.01., indemnity lost wage benefits in the amount of \$32,091.84., for a total expenditure of \$121,117.85. However, since the employees injury was sustained in an automobile accident, the Counties lien must be reduced by \$50,000 dollars, therefore, the Counties net lien is \$71,117.85. Based on the review of the facts and circumstances, this office seeks the authority to compromise the lien for reimbursement by reducing the lien by 34.92%, equaling a dollar reduction of \$24,834.35. The County would thereafter accept a total of \$46,285.50.

On motion of Legislator Pierce, seconded by Legislator Tubiolo, the above item was signed by committee and referred to Board of Legislators. The motion carried.

#### ACT-2023-97 ACT - Settlement of Workers Comp Lien (L.C.)

AN ACT authorizing the County of Westchester to compromise its right to be reimbursed for health care and wage benefits paid to or on behalf of a County employee from a settlement of his legal action against a third-party tortfeasor.

Senior Assistant County Attorney Sean Carey appeared before the Committee to discuss the item. Mr. Carey explained that there are two types of workers compensation cases that the County regularly sees. First is a case in which the County has a lien on the proceeds of a third part settlement, and the second is a matter where there is a lump sum settlement to offset future expenses that the County will owe to the employee. This case is the first type with an accident that occurred where the County laid out money as part of its workers compensation program and is more capable of recovering it in the settlement of that third party action. Mr. Carey discussed that this incident occurred in 2021 when a senior case worker at DSS fell down the steps of a home that he was visiting for a site visit, within the scope of his employment. He filed a workers compensation claim, which was uncontroversial and on a parallel track to the claim to commence personal injury action against the owners of the property where he fell. In February 2023 they agreed in principal to settle the personal injury claim for \$33,901.27. In connection with the proposed settlement, council notified the County Attorneys office that the cost disbursements and legal fees total \$11,806.37. Mr. Carey noted

that the County's expenditures in this matter were relatively slight. Between the date of the accident and the date of the proposed settlement, the County expended medical benefits, pursuant to the compensation law, in the amount of \$5,986.30. No indemnity payments were made so the employee did not miss any time. Based on a review of the facts and circumstances of this matter, this office seeks the authority to compromise the County's claim for reimbursement by reducing its lean 34.83%, equaling a dollar reduction of \$2,085.03. The County would accept a total of \$3,901.27. After the County is reimbursed and counsel fees are paid, the employee receives \$18,193.63.

On motion of Legislator Tubiolo, seconded by Legislator Barr, the above item was signed by committee and referred to Board of Legislators. The motion carried.

#### ACT-2023-103 ACT - City Of Yonkers - National Night Out

AN ACT authorizing the County of Westchester to enter into an inter-municipal agreement with the City of Yonkers, acting by and through its Police Department, pursuant to which the City will provide its National Night Out program within the period from January 1, 2023 through December 31, 2023 for a total amount not to exceed FOUR THOUSAND, TWO HUNDRED EIGHTY (\$4,280.00) DOLLARS.
