

RESOLUTION NO. 144 - 2024

ADOPTED 08/05, 2024 PROVIDING FOR THE PUBLICATION OF COUNTY LOCAL LAW INTRO NO. 2024-307 AND NOTICE OF SUBMISSION OF A PROPOSITION THEREON AT A GENERAL ELECTION TO BE HELD ON NOVEMBER 5, 2024.

BE IT RESOLVED BY THE BOARD OF LEGISLATORS OF THE COUNTY OF WESTCHESTER, AS FOLLOWS:

Section 1. The Clerk of the County Board of Legislators is hereby directed to cause to be published a copy of an abstract of Local Law Intro. No. 2024-307, adopted by the County on July 17, 2024, together with a Notice that a Proposition for the approval or disapproval of said Local Law shall be submitted at the general election to be held on November 5, 2024, such publication to be made once in each of the six weeks immediately preceding said election, in each of the following newspapers having a general circulation in the County of Westchester, which newspapers are hereby designated the official newspapers for the purpose of said publication:

WESTCHESTER HISPANO (All Westchester County editions)

Section 2. Said Notice shall be in substantially the form as follows:

NOTICE IS HEREBY GIVEN that Local Law Intro. 2024-307, has been adopted by the County Board of Legislators of Westchester County, New York on July 17, 2024, and a Proposition for the approval or disapproval of said Local Law will be submitted to the electors of the County at the general election to be held on November 5, 2024.

The Local Law, entitled “A LOCAL LAW amending Chapter 107 of the Laws of Westchester County to modify the length of terms for Westchester County Legislator,” modifies the length of terms for individuals who will be elected to the position of Westchester County Legislator, beginning with the 2025 election, to increase the length of term from two years to four years. The Local Law also makes other technical modifications to align the language of the Laws of Westchester County to account for four year terms.
