A section of the order, "Suspension of law allowing the attendance of meetings telephonically or other similar services," provides for the suspension of "Article 7 of the Public Officers Law, to the extent necessary to permit any public body to meet and take such actions authorized by the law without permitting in public in-person access to meetings and authorizing such meetings to be held remotely by conference call or similar service, provided that the public has the ability to view or listen to such proceeding and that such meetings are recorded and later transcribed."

RES-2021-23 RESO - OPPOSING FRACKING-RELATED DEVELOPMENT AT THE FORMER DANSKAMMER ENERGY SITE

areas will be harmed by the project, and the overall economic benefits to Westchester County and adjacent counties of pursuing battery storage and other alternatives for the proposed plant.

Chair Parker introduced Santosh Nandabalan, from Food and Water Watch, and Hannah Adler, from Sunrise Westchester to speak in support of the item. Chair Parker and Chair Walter (E&H) both spoke about the potentially disastrous effects to the community and the environment if a fracked natural gas operation was allowed at the site, before turning it over to the guests. Mr. Nandabalan and Ms. Adler both spoke about their organizations' efforts in promoting renewable energy and further elaborated about the negative effects of operating a fracked gas plant at this site. They highlighted the widespread public opposition to its opening. Chair Parker asked about the plant's impact on communities of color, to which Mr. Nandabalan said that environmentalism and social justice went hand in hand as people of color were most often hurt by pollution and special interest policies. Vice-Chair Barr and Legislator Shimsky praised their efforts and the committee thanked them for their activism.
