Transmitted herein is an act authorizing the amendment of the 2022 County Airport Budget in the amount of \$1,710,000, and the 2022 County Special Districts Budget in the amount of \$8,418,000.

Pursuant to Section 167.121 of the Laws of Westchester County, this Act requires authorization by the Board of Legislators.

The attached Act contains an increase of \$1,710,000 in appropriations for additional expenditures, primarily utilities, cash to capital, and PFC to capital. This increase is fully funded by additional revenue from PFC recognition and fuel charges.

Also included in this requested amendment are appropriations increases for debt service within the County's sanitary sewer district funds as well as increases in overtime, healthcare, utilities and chemicals relating to sewer operations. Utilities increased at a higher rate than anticipated throughout the County, combined with an expiring major chemical contract that needed to be renewed during a period of high inflation. In addition, higher than anticipated overtime and healthcare costs which caused Sewer Operations to need additional appropriation. This increase is fully funded by additional ARPA funding.

Therefore, I recommend the approval of the attached Act amending the 2022 County Airport Budget in the amount of \$1,710,000, and the 2022 County Special Districts Budget in the amount of \$8,418,000.
