Your Committee recommends passage of "An Act approving Lisa Daley as a member of the Westchester County Board of Ethics."

Your Committee is informed that pursuant to section 883.401 of the Laws of Westchester County, the Board of Ethics shall consist of seven members, five of whom shall be appointed by the County Executive, and two of whom shall be appointed by the Chair of the Board of Legislators. The members appointed by the County Executive shall be subject to confirmation by the Board of Legislators, while the members appointed by the Chair of the Board of Legislators shall be subject to approval by Act of the Board of Legislators.

Your Committee is further informed that Catherine Borgia, Chair of the Board of Legislators has appointed Lisa Daley to serve as a member of the Board of Ethics for a term to expire on December 31, 2024. Ms. Daley is currently the Managing Attorney at My Sisters Place and has worked as an attorney at the New York City Administration for Children's Services and for District Council 37 Municipal Employees Legal Services Plan. She is also a registered nurse who has worked at NYU Langone Medical Center, where she worked as a Patient Safety Risk Manager as well.

Your Committee therefore recommends approval of the appointment of Lisa Daley as a member of the Board of Ethics.


§ 2. The appointment of Lisa Daley to the Board of Ethics is hereby approved for a term to expire on April 1, 2024.
