ACT-2023-144 BOND ACT-BIT54-Critical Communication Logging System Replacement '21-'25

Mr. Lenox explained the need for replacement of audio equipment that is used across county departments. He said the current equipment has reached its shelf life and needs to be upgraded and modernized. In addition, new software needs to be purchased.

Legislator Woodson-Samuels asked when the software had been acquired and Mr. Lenox responded that he believes its been about 5 years.

Legislator's Pierce and Legislator Maher asked about the type of audio recordings associated with this equipment and the departments. Mr. Lenox provided examples that included the 911 recordings used by DES and the phone calls used by DSS during CPS cases and/or when registering people for benefits.

ACT-2023-137 ACT-Procurement of Bell Model 407 Helicopter

It was explained that item is seeking approval to modify the procurement policy to allow a more specific bidding process that would ensure that bids for Bell Model 407 Helicopter is the only bids being received. The option to modify this law is made available by a municipal law exception that allows a efficiency or economy reason for specifying specific models in a bidding process. The reason this situation satisfies those exceptions is because purchasing a different model would double pilot training costs, increase equipment costs and create potential difficulty in operations due to having different aircrafts.

It was emphasized that passing this law does not disqualify the public bidding process.

Legislator Woodson-Samuels asked if the Bell Model 407 was the top of the line model and are there other municipalities using the same aircraft?

Mr. Luciano explained that this model is the best suited for Westchester County needs which may differ from the needs of surrounding counties.

Legislator Barr asked for clarity around whether it may be useful to have aircrafts of different models to serve different purposes that would be of benefit to the County?

Mr. Luciano reiterated the Bell Model 407 being the best suited helicopter for the County. He also added it is the best within our budget.
