

**HONORABLE BOARD OF LEGISLATORS
THE COUNTY OF WESTCHESTER, NEW YORK**

Your Committee is in receipt of a communication from the County Executive requesting that this Honorable Board authorize the County of Westchester, acting by and through its Office for Women, ("County") to enter into an agreement with the Westchester County Health Care Corporation ("WCHCC"), pursuant to which WCHCC would provide free culturally-competent bilingual services for victims of sexual assault residing in the County through its Sexual Assault, Abuse and Victim's Empowerment ("SAAVE") Program, for the term commencing retroactively on January 1, 2025 and continuing through December 31, 2027, for a total amount not to exceed Eight Hundred Seventy Thousand (\$870,000.00) Dollars, payable in accordance with an approved budget ("Agreement"). The funding amount for calendar year 2025 will not exceed Two Hundred Thousand (\$200,000.00) Dollars. The funding amount for calendar years 2026 and 2027 will not exceed Three Hundred Thirty-Five Thousand (\$335,000.00) Dollars per year.

Your Committee is advised that according to the 2010 census, the foreign born population of the County accounts for almost 24% of the population, evenly split between naturalized US citizens and non-citizens with Hispanics accounting for more than 20%. It is generally accepted that the number of Spanish-speaking mono and bilingual residents has been growing and is actually much greater than the numbers stated. The needs of this community for services for victims of sexual assault have increased with the increase in population. It is estimated that only 16% of sex crimes are actually reported statewide, making it difficult to accurately estimate the number in the County. The trauma associated with sexual violence creates a significant health burden for survivors of sexual assault. These health problems can lead to hospitalization, interruptions in ability to work, disability, and death.

Your Committee is advised that the services to be provided by the WCHCC through its SAAVE Program pursuant to the proposed Agreement will include access to a bilingual, 24/7 County-wide hotline for victims of domestic violence and sexual assault; crisis counseling and advocacy; accompaniment to appropriate resources including sexual assault exams, police, hospitals, and other providers; comprehensive outreach; education; follow-up; and other related culturally-competent services.

The Planning Department has advised that based on its review, the proposed Agreement does not meet the definition of an "action" under New York State Environmental Quality Review Act and its implementing regulations 6 NYCRR part 617. Please refer to the memorandum from the Department of Planning dated January 14, 2025, which is on file with the Clerk of the Board of Legislators.

Your Committee has been advised that Section 3307(4) of the New York Public Authorities Law requires the approval of your Honorable Board and the Board of Acquisition and Contract for this Agreement. Pursuant to that section, said approval of the Board of Legislators must be by an affirmative vote of not less than a majority of the voting strength of the County Board of Legislators.

Your Committee has carefully considered and recommends approval of the proposed Act.

ACT NO. 2025 - _____

An Act authorizing the County of Westchester to enter into an agreement with the Westchester County Health Care Corporation, for the term commencing retroactively on January 1, 2025 through December 31, 2027, pursuant to which the WCHCC shall provide free culturally-competent bilingual services for victims of sexual assault residing in Westchester County.

BE IT ENACTED by the County Board of the County of Westchester as follows:

Section 1. The County of Westchester ("County") is hereby authorized to enter into an agreement with the Westchester County Health Care Corporation ("WCHCC") to provide free culturally-competent bilingual services for victims of sexual assault residing in the County through its Sexual Assault, Abuse and Victim's Empowerment (SAAVE) Program, including but not limited to: access to a bilingual, 24/7 County-wide hotline for victims of domestic violence and sexual assault; crisis counseling and advocacy; accompaniment to appropriate resources including sexual assault exams, police, hospitals, and other providers; comprehensive outreach; education; follow-up; and other related services, for the term commencing retroactively on January 1, 2025 and terminating on December 31, 2027, for a total amount not to exceed Eight Hundred Seventy Thousand (\$870,000.00) Dollars, payable to WCHCC pursuant to an approved budget. The funding amount for calendar year 2025 will not exceed Two Hundred Thousand (\$200,000.00) Dollars. The funding amount for calendar years 2026 and 2027 will not exceed Three Hundred Thirty-Five Thousand (\$335,000.00) Dollars per year.

§2. The County Executive or his authorized designee is hereby authorized and empowered to execute all instruments and to take all action necessary and appropriate to effectuate the purposes hereof.

§3. This Act shall take effect immediately.
