

ACT 133 - 2023

TO THE HONORABLE BOARD OF LEGISLATORS  
COUNTY OF WESTCHESTER, NEW YORK

Your committee is in receipt of an Act authorizing the transfer of appropriations across County departments in the amount of \$61,177,000. These transfers are required to complete the 2022 fiscal year on a sound financial basis, and are fully funded by savings within the 2022 Operating Budget.

Pursuant to Section 167.121 of the Laws of Westchester County, this Act requires authorization by the Board of Legislators.

The attached Act contains an increase in the appropriations for various departments. Increased appropriations are needed primarily for higher than anticipated energy costs, distribution of sales and use tax collections to the municipalities and school districts, bus operating assistance costs increased due to reduced fare box revenue, employee health insurance, and a transfer to the County's workers compensation fund. These increases are fully funded by savings from other departments, primarily the Children with Special Needs programs, during fiscal year 2022.

Therefore, the committee recommends approval of the attached Act in the amount of \$61,177,000 for the 2022 County Operating Budget.
