### 2. <u>2024-70</u> <u>PH-Term Lengths and Timing of Elections for Westchester County</u> Legislator and County Executive

Guests: Law Dept.: Justin Adin, Deputy County Attorney, and Mark Gardner, Senior Assistant County Attorney

Mr. Adin explained that New York State recently passed a law which moves elections for County Legislator and County Executive to even-numbered years. The law will take effect on January 1, 2025, and impact the County's 2025 election year. He further explained that the County law needs to be amended to conform to the State law and realign the election schedules.

Mr. Adin said that this law will mandate that County Legislators elected in 2025 will serve for one year in 2026. An additional election for will then be held in 2026, where County Legislators will serve the requisite two-year term. A legislator's one-year term in 2026 will not be counted under the County's term limit requirements unless the County specifically passes a law to do so. He stated that the law also provides that the County Executive elected in 2025 will serve for three years. An additional election will be held in 2028, and the County Executive will serve the requisite four-year term. The three-year term for County Executive from 2026 through 2028 will not be counted under the County's current term limits law unless the County specifically passes a law to do so.

Mr. Adin added that these requirements will take effect by operation of State law, whether or not the County amends its laws, so this legislation will conform the County law.

Legislator Cunzio noted that at least one county has indicated that they will file a lawsuit challenging the validity of the State law on the grounds that the County has their own charter, so the State cannot dictate this. She questioned whether we should wait for a resolution of that issue before changing our law. Mr. Adin said that we can amend the effective date of the County law to the same time as the relevant sections the State law, so that if the State law is struck down, the County law will never go into effect. He also said that if we pass the County law without amending the effective date and the State law if found to be invalid, the County law wouldn't actually go into effect because it is subject to a mandatory referendum in that situation. The only reason it is not required in the current legislation is because the State law mandated it.

Mr. Adin suggested that Section 6 of the draft law be amended as follows: "This Local Law

shall take effect on the same date as Section 3 of Chapter 741 of the 2023 Laws of the State of New York, except that each section with a later effective date shall take effect on the date specified therein."

The committee members agreed on the amendment.
