A necessity exists for the enactment of this legislation because the local government does not have the power to enact such legislation by local law.



Such demonstration program shall 10 empower such county to install and operate traffic-control signal photo 11 violation-monitoring devices at no more than fifty intersections within 12 and under the jurisdiction of such county at any one time. Provided 13 that, in addition to the fifty intersections within and under its juris-14 diction. such county may install and operate traffic-control signal 15 photo violation-monitoring devices on at no more than one intersections located on the 16 portion of the Saw Mill River parkway within such sounty that is in the 17 village of Pleasantville, upon assessment with the commissioner of the 18 state county of Westchester, upon approval in writing obtained by such county from the department of transportation or such commissioner's decisioner. provided that the department of transportation may at any time rescind or modify such approval. 19 § 2. § 2. The county of Westchester and commissioner of the New York state 1 department of transportation are hereby authorized and empowered to 2 install signage giving advance notice to motor vehicle operators of the 3 presence of traffic-control signal photo violation-monitoring devices 4 operated pursuant to a demonstration program authorized by article twen-5 ty-four of the vehicle and traffic law, in conformance with standards 6 established in the manual on uniform traffic control devices maintained 7 by the commissioner of transportation pursuant to section sixteen 8 hundred eighty of the vehicle and traffic law. Provided, however, that 9 the county of Westchester shall not place or maintain such signage on 10 the Saw Mill River parkway unless or until approval in writing has been 11 obtained from the New York state department of transportation, and such 12 department of transportation may at any time rescind or modify such approval. The county of Westchester is additionally authorized to 13 14 design and implement a public information campaign before traffic-con-15 trol signal photo violation-monitoring devices authorized pursuant to 16 the provisions of paragraph one of subdivision (a) of section eleven 17 hundred eleven-g of the vehicle and traffic law, as amended by section 18 one of this act, go into operation, to notify and educate motor vehicle 19 operators about such demonstration program. 20

\$ 3. This act shall take effect immediately; provided that the amendments to section 1111-g of the vehicle and traffic law made by section one of this act shall not affect the repeal of such provision and shall be deemed repealed therewith.
