I am a founding member and an administrator of a Facebook group, "Women for Social Change" which has over 6000 members from all over the US and the world. The objective of this group is-

- to focus on women's empowerment.
- work towards improving the quality of life of women by creating awareness about the rights of women and encourage them to advocate for themselves.
- give women a judgement-free safe space to express themselves and ask questions.
- provide information for self-improvement in education, health, career and family life.
- organize collection drives during Thanksgiving and Christmas, for women and children living in shelters.
- organized ZOOM events where healthcare professionals answered questions and offered advice on women's health focusing mainly on menopause, mental health and other women related health concerns.
