### MINUTES APPROVAL

### I. ITEMS FOR DISCUSSION

1. RES-2024-57 ENV RES-Westchester Joint Water Works (WJWW)

AN ENVIRONMENTAL RESOLUTION to adopt a Findings Statement.

Legislator Smith read into the record a memorandum from Legislator David Imamura recusing himself from this matter due to his law firm's representation of several involved parties.

Legislator Smith noted that at the last meeting, the legislators requested revisions to the draft. He also noted that the BOL is required to adopt SEQRA findings before it can vote on the Act. He said that pursuant to the SEQRA regulations, the County Planning Department prepared a

recommended statement of findings. This was done after the Planning Department conducted its own thorough and detailed analysis of potential impacts and proposed mitigation measures and reviewed them in context with our County policies.

Legislator Smith asked Mr. Nonna to explain why adoption of the SEQRA Findings Statement is legally required. Mr. Nonna said that the County, as an involved party, needs to adopt its own findings, as distinct from the findings of the Lead Agency.

Planning Department Commissioner Blanca Lopez discussed the draft recommended Findings Statement. Claudia Maxwell, Principal Environmental Planner, said that the section regarding Hazardous Materials needs to be corrected. The statement "No detectable levels of PFAS were found on the disposition property in either prior County sampling or in more recent soil and groundwater testing undertaken for the project" should be revised to clarify that the County did not do sampling on the disposition property, because they did not have to. She explained that the sampling was done in the area where the PFAS was found, which was far removed from this area.

# 2. ACT-2024-61 ACT - Exchange of 13.4 Acre Parcel of County Property with Westchester County Joint Water Works

AN ACT authorizing the County of Westchester to 1) convey to the Westchester Joint Water Works a parcel of County property that is currently part of the Westchester County Airport and located near the intersection of Tower Road and Purchase Street, in order to facilitate the plan to construct and operate a water filtration facility, subject to all necessary legal approvals, 2) accept from Westchester Joint Water Works a parcel adjacent to the Airport, and 3) grant to Westchester Joint Water Works an easement across Airport property permitting connection to the existing sanitary sewer line on Airport property.

Mr. Nonna discussed the changes to the legislation. He said that Section 4 now makes it explicitly clear that the NYS DEC will retain jurisdiction and oversight with respect to activities which could impact the Brownfield Cleanup Program. He added that Section 5 provides that WJWW will allow the County access to the parcel to fulfill its Brownfield obligation and to construct the sewer connection. Section 6 provides that WJWW shall indemnify the county for any claims arising out of the design, construction or operation of the water filtration facility.

Mr. Nonna said that the paragraph 6 of committee report states that the easement conveyed by the County to WJWW to connect the water filtration facility to the existing sanitary sewer line "may be subject to FAA consent." He said that April Gasparri, Airport Manager, spoke to the FAA, and they confirmed that it is not, so that language needs to be removed.
