1. ACT-2023-193 ACT - Retain Bryant Rabbino LLP as Bond Counsel

AN ACT authorizing the County of Westchester to retain the law firm of Bryant Rabbino LLP as bond counsel to act in an "of counsel" capacity to the County Attorney on an "as needed" basis, for the period commencing upon execution of the agreement by both parties and terminating on July 31, 2024, and to amend the existing bond counsel agreements with the law firms of Hawkins, Delafield & Wood LLP, Norton Rose Fulbright US LLP; and Harris Beach PLLC in order to reflect the addition of the fourth bond counsel to the County.

Mr. Nonna and Ms. Altschiller discussed the item. This Act will retain the law firm of Bryant Rabbino as bond counsel to act in an of counsel capacity to the County Attorney on an as needed basis, for the period commencing upon execution of the agreement and terminating on July 31, 2024; and amend the existing agreements with Hawkins, Delafield & Wood, Norton Rose Fulbright, and Harris Beach to reflect the addition of Bryant Rabbino as a fourth bond counsel to the County that will share in the aggregate amount not to exceed \$450,000 through July 31, 2024. Mr. Nonna noted that this is a minority-owned law firm with an excellent reputation, so they will be a good addition.

2. <u>ACT-2023-194</u> ACT - Settlement of Workers Comp Liem "A.Y."

AN ACT authorizing the County of Westchester to compromise its claim to be reimbursed for health care expenditures and wage benefits paid to or on behalf of a County employee from a settlement of her legal action against a third-party tortfeasor.

Mr. Carey discussed the item. He advised that on February 11, 2021, A.Y., a social worker for DSS, slipped and fell while trying to locate a customer's family home. She fractured her left

wrist, and required surgery. She was out of work for just over six months.

A.Y. filed a claim a Workers Compensation claim, and brought a personal injury action against the property owners. On or about June 20, 2023, A.Y. agreed to settle her personal-injury action for \$195,000, pending the County's consent. In connection with the proposed settlement, A.Y. 's counsel advised that its costs and disbursements total \$4,029.65 and the attorney's fee totals \$65,000, for a total litigation cost of \$69,029.65. Between the date of the accident and the date of the proposed settlement, the County expended medical benefits pursuant to the NYS Workers' Compensation of \$21,096.79 and indemnity (lost wage) benefits in the amount of \$53,076.22, for a total of \$74,173.01 in total County expenditures.

The County seeks authority to compromise its claim for reimbursement by reducing its lien by 35.40%, equaling a dollar reduction of \$26,257.25. The County would thereafter accept in satisfaction of its present lien a total of \$47,915.76. After the County is reimbursed and counsel fees are paid, A.Y. would receive \$78,054.59.

Captain Greer explained that the radios are being upgraded to correct an issue that has been going on for a few years. Because there are mutual aid events everyday, upgrading the system will help to coordinate safely.

Legislator Barr mentioned that during an earlier meeting it was discussed that these upgrades were done for the fire department 20 years ago, so this legislation is to catch everybody up. She also mentioned a question that was brought up around using cell phones to communicate, but it was determined this is the best way to communicate during emergencies.

Legislator Clements asked how the amount of radios for each police department be decided.

Captain Greer responded that although there are many police departments, a lot of the towns and villages only have a small number of cars deployed on a tour. Essentially it'll depend on the amount of radios the Department has taken need and practical deployment into perspective.

Legislator Smith reiterated his support for this project but wanted to ask if the upgrades that are now bringing the Police Department up to speed with the Fire Department, include the local emergency services departments. Chief Volk said that each municipality should have a designated office of emergency services and the county will allow local emergency management groups to be added to support the lager operation.

Mr. Cirillo and Dr. Miles discussed the item. Mr. Cirillo said this bond act will fund a complete renovation of a building now used as storage. Dr. Miles said that they would like the facility to be available for specialized academic programming.

Legislator Pierce asked what will be done to ensure the building is energy efficient. Mr. Cirillo said they will have energy efficient boilers, cooling system, and windows, and LED lighting.

Legislator Parker asked if they have a consultant looking at the technology for green infrastructure. Mr. Cirillo said this is for the design and construction phase of the project, and he will then look at a list of consultants. Legislator Parker asked that we use the term electrification instead of energy efficiency. Legislator Pierce suggested looking into heat pumps or geothermal to get away from using a boiler. Mr. Cirillo said that when he prepares the RFP for the list of consultants, he will include it.

This phase will include academic technology initiatives, Storage Area Network growth and replacement of media equipment; wireless enhancements, firewall replacement and digital signage replacement. It also includes laptops, PCs, phones, printers, scanners, servers, switches, tape drives, and UPS wireless, which are mostly on a five-year replacement cycle. The total cost of Phase IV is \$1,200,000, of which 50% will be funded by New York State and 50% by the County.

The Tromberg firm (under a prior name) has been providing this service to WCC since 2014. WCC issued an RFP in April 2023, and Tromberg was the only firm to respond to WCC's RFP in April, 2023.
