1. ACT-2024-143 CBA-RGI04-Glen Island Bridge Rehabilitation III

AN ACT amending the 2024 County Capital Budget Appropriations for RG104 Glen Island Bridge Rehabilitation III.

Mr. DeLuca explained that Hartesty and Hanover put together the estimate in November of 2023 and at that time the estimate was feasible and accounted for inflation costs as trended after COVID. However, since then, several materials increased drastically (like copper for example) and very few contractors with enough supplies to conduct the work on this project. He added that Hartesty and Hanover is a reputable consulting firm with expertise on moveable bridges throughout the country that can be trusted to get this work done and this unforeseen circumstance is actually rare. Typically, in other bids the builder does not share the cost breakdown, however they only learned about the exact bid cost totals in the tristate area until a week before this meeting. In his cost explanation, Mr. DeLuca provided a general overview on those bids and how they can contribute to the steep price increase that are now affecting this project.

Mr. Tartaglia shared that within the department's options for this bridge there were other possibilities that did not include building a temporary bridge, however due to the needs of Coast Guard, local use and efficiency, building a temporary bridge is the best solution to accommodate usual access.

Once the contract is awarded, that is the amount that it will be and they would not return in the future for increased funding for this project as it includes contingencies. Hartesty and Hanover has an estimating team that uses a combination of resources, including the State's website, to ensure having the most accurate data possible. Once rehabilitated, there is no reason to believe that the bridge will not last less than 50 years.
