PH-Establishing a Subcommittee of the African American Advisory 1. 2023-187 **Board**

A RESOLUTION to set a Public Hearing on "A LOCAL LAW amending Section 277.421 of the Laws of Westchester County to add a provision to establish a Subcommittee of the Westchester County African-American Advisory Board to study the high rates of asthma in communities of color in the County of Westchester." [Public Hearing set for .m.]. LL Intro: 2023-188.

COMMITTEE REFERRAL: COMMITTEES ON LEGISLATION AND APPOINTMENTS

Chair Nolan and Legislator Barr invited the guests to introduce themselves and begin the discussion on this item. Ms. Dolgin-Kmetz explained that this is a five (5) member sub-committee appointed by the County Executive and with the Commissioners of the Departments of Health, Social Services and Planning (or their designees) as ex-officio members. Their task is to assess the asthma risks for minority residents in the county that lead to identify barriers for quality asthma treatments, developing intervention strategies and launching a countywide asthma awareness campaign to educate County residents on how to manage this disease better. The sub-committee will then deliver an annual report with trends and data to the County Executive and the Board of Legislators as of September 1, 2025.

Dr. Amler and Deputy Commissioner Recchia explained that there are two sources of data that they receive to assess asthma, one via a telephone survey and the other is based on emergency room visits that looks at adults and children. When narrowing down by zip codes for people between the ages of 0 to 18, from 2018 to 2020 Westchester County's rate was at 65.4 and New York State's rate was 48.5 (excluding New York City). From surveys and studies like these, it was determined that minorities were predominately asthmatic. As a way to help circumvent this issue the Department of Health determined that they would find it beneficial to have a sub-committee for the African American Advisory Board. Dr. Amler explained that asthma can derive from several sources, such as air quality, as it is a multi-factorial condition that manifested from an array of ways. The Westchester County zip codes with the highest rates of asthma diagnoses included 10701, 10703 and 10705.

Some of the committee members expressed that the Board of Legislators should have input in appointing the members of this subcommittee. Ms. Dolgin-Kmetz added that although the Board does not appoint the sub-committee members, the Board does have a say in whose appointment gets confirmed for the African American Advisory Board in general. Other suggestions made by the committee members included ensuring that there is a pulmonologist on the subcommittee, updating the committee report's first line and requiring geographical representation for environmental justice communities. Additionally, the committee members requested the asthma rates regarding fuel consumption in the last few years and the report for the survey mentioned.

Chair Nolan and Legislator Barr thanked the guests and proceeded to conclude the meeting. This RESOLUTION - Public Hearing was continued
