Legislator Pierce asked what other options were looked at, i.e., geothermal or heat pumps. Mr. Cirillo said these are older buildings, and it was not cost efficient to use alternatives. He said he will check the Master Plan to see what alternatives were explored, and let her know. Legislator Pierce emphasized that every project that comes before the committee should look toward getting away from natural gas and oil.

Legislator Pierce also noted that we should show the savings to the operating budget from using solar panels on the impact statement, and for all of these types of projects going forward. Mr. Tartaglia said he will mention that to the Budget and Finance Departments.
