# I. ITEMS FOR DISCUSSION

#### 1. ACT-2024-81 BOND ACT-BPL26-2448-Flood Mitigation

A BOND ACT authorizing the issuance of TWO MILLION (\$2,000,000) DOLLARS in bonds of Westchester County to finance Capital Project BPL26 - Flood Mitigation. **SUBMITTED BY: COMMITTEES ON BUDGET & APPROPRIATIONS AND PUBLIC WORKS & TRANSPORTATION** 

Guests: Planning Department Commissioner Blanca Lopez Chief Planner Susan Darling Program Director of Community Development Len Gruenfeld This item authorizes \$2 million in bonds to finance Capital Project BPL26 which addresses projects and strategies to reduce flooding in Westchester County. The Department of Planning has a watershed-wide approach to understand flooding in this region and how to best remedy this issue. The New York State Department of Environmental Conservation is preparing watershed-based flood mitigation plans for a portion of the watersheds in Westchester through the New York Resilient Program. The funding requested in this item is to plan for the areas not accounted for in the previously mentioned program and will include the creation of surveys, outreach to municipalities and the creation of detailed project plans and paperwork needed to apply for additional funding sources. They have been working with Department of Environmental Conservation (DEC), and anticipate beginning in a couple of weeks to a month and completing the work within the next three years. This project will also be under the purview of the newly created position, Director of Flood Mitigation and Resiliency.
