Emergency Medical Services should be considered essential service in New York State

Chair Williams Johnson provided an overview on the topic and invited the guests to introduce themselves. Assemblyman Steve Otis spoke about the proposed legislation that he and Senator Shelley Mayer sponsored for the State of New York last year (Assembly bill A 3392-A and Senate bill S4020-A). Commissioner Wishnie and Deputy Commissioner Spear explained why they are in support of this initiative after sharing a short trailer for a documentary on how Emergency Medical Services (EMS) employees were impacted by the pandemic despite not being considered essential services during that time. Mr. Greenberg provided an overview on New York State's EMS Future Agenda and how they obtained the relevant information that helped them develop this document. Ms. McIlroy provided insight on a recently signed law for community-based paramedicine demonstration programs (Assembly bill A6683-A and Senate bill S06749-B). She explained that during the past couple of years there have been about 50 community paramedicine programs created to operate with the flexibility authorized under Executive Order No. 4 of 2021, allowing the treatment of non-emergent incidents, which in turn reduced the amount of people in emergency rooms. This law focuses on existing programs allowing those services for the next two years, regardless of what happens with the Executive Order, and also created a stakeholder advisory panel to look at the programs and determine best practices.

The continued discussion included varying experiences from the guests and how nearby counties are also impacted by similar issues, such as lack of funding for example. Among the questions asked there was mention that if EMS becomes an essential service, it would be up to that municipality to determine what that may look like as well as making them responsible for overall costs and services.

After further discussion, Chair Williams Johnson thanked the guests and proceeded to conclude the meeting.
