MINUTES APPROVAL

I. ITEMS FOR DISCUSSION

1. <u>2022-96</u> <u>PH-Greenwich Woods Wastewater Discharge Permit</u>

Guests: Dept. of Environmental Facilities: Commissioner Vincent Kopicki and Director of Maintenance Marian Pompa; Law Dept.: Senior Assistant County Attorney Jeff Goldman Mr. Goldman explained that the legislation would extend the discharge permits for the Greenwich Woods Assisted Living Facility. He noted that the original agreement dates back to 1985, and the current permit was issued in 2000 and is set to expire in 2029. The applicant seeks a 35-year permit extension until 2064 because they are refinancing their debt and the lender requires an extension of the permit as part of their refinancing agreement. County permits are for three year periods, and while there have been carve outs, there was none issued for this permit. The request before committee is to retroactively seek a carve out to extend the permit.

Legislator Maher asked if this would still contain easements, and Mr. Goldman confirmed everything will stay the same except for the end date. Legislator Maher asked if this was the

property near the airport that some legislators had concerns about, and Legislator Barr said no. Legislator Barr asked if the Blind Brook Sanitary Sewer System would be able to handle this due to the amount of development in the region since 2000, and Commissioner Kopicki and Mr. Pompa confirmed that the amount discharged by this property (roughly 14,000 gallons per day) is well below the amount allowed of 50,000 gallons per day, and their system had a 5M tank and could handle a maximum flow of 1.5 million gallons per day. The legislators asked whether the amount of fees collected were appropriate from the facility, and Commissioner Kopicki and Mr. Pompa confirmed that it was, collecting roughly \$80,000 in fees last year. Legislator Smith asked about the apparent disinclination for short term extensions, and it was agreed that it was a lot of work that needed to be put in every few years and ended up not saving any time. In this case, it made sense to grant the extension for something that generated a sizeable amount of fees and had a relatively small impact on the system.

Legislator Gashi raised concerns about the fee structure, and Legislator Pierce asked if the residents of the sewer district have had increases which the facility had not. Mr. Pompa confirmed that there have been increases, and the applicant in this case has not been paying a flat fee since 1985.
