

In 2016, Judge Scarpino was elected District Attorney of Westchester County, supervising a staff of over 240 attorneys, investigators, and support staff. As Westchester County D.A., Judge Scarpino enacted sweeping criminal justice reform, including putting in place the Discovery statute, ending cash-bail and pre-trial detention for non-qualifying cases, and “Raising the Age” for teen offenders.
