1. ACT-2021-168 ACT - WCC Covid Testing Services

AN ACT authorizing the County of Westchester to enter into an agreement with the Westchester County Health Care Corporation, d/b/a Westchester Medical Center, for a term commencing on October 7, 2021 and expiring on October 6, 2022, for Covid-19

nasopharyngeal testing services to WCC's staff, faculty and student for potential risk exposure to the Coronavirus Disease.

Vice President Murphy and Directors Glass and Sullivan appeared before the committees to discuss the Act- WCC-COVID Testing. Westchester Community College (WCC) in compliance with The State University of New York's COVID-19 safety protocols and the public health directives issued by the Governor and the Department of Health, this Act is to enter into an agreement with Westchester County Health Care Corporation d/b/a Westchester Medical Center (WCHCC). WCHCC would provide Covid-19 nasophayngeal testing to WCC faculty, staff and students for potential risk exposure to the Coronavirus disease, for a term commencing on October 7, 2021 and expiring on October 6, 2022. The County would pay a fee not to exceed \$1,000,000 for the term of the agreement.

Director Sullivan discussed that this testing is for the unvaccinated population on campus. SUNY mandated that all of their students to be vaccinated, and it will be on about September 27th that they will have to at least had their 1st shot. There are exemptions, religious and medical exemptions, not everyone will be vaccinated in the student population and the same is true for the employee population.

Director Sullivan explained that there is another component that is being discussed, SUNY may require us to increase our testing a surveillance testing for vaccinated people who were on the campus, both students and employees. Testing numbers may go up, which is why the estimated calculation is at that \$1 million.

Guests: Lynne Colavita, Senior Assistant County Attorney & Chris Steers, Real Estate Director Senior Assistant County Attorney Lynn Colavita and Real Estate Director Chris Steers appeared before the committees to discuss Convey Real Property - Jefferson Street, Town of Mamaroneck. This item was discussed earlier this year but held over by the Law Department for further negotiations of the sale price.

Ms. Colavita explained that originally this small property was acquired in the 1920's for use of a parkway, which never was used. The adjacent property is a Co-op and they are approached the County to purchase the property for use of a small playground and sitting area for resident. The County went through the protocols compliant with the law and offered it to the town they did not wish to purchase it for a dollar for parks purposes, and the Parks Board deemed it no longer useful for parks purposes.

Ms. Colavita discussed that before the committees is revised legislation to convey 0.17 acres of vacant land to Calshire Tenants, Inc. This conveyance would be a quitclaim deed for the consideration a reduced price of \$12,000. The Director of Real Estate advised that the property was appraised and given a market value of \$17,600, however subsequent to the appraisal the property sustained damage to several trees. It was noted that the reduced sale price was to cover the cost of the tree damage and removal.

Commissioner O'Connor, First Deputy Commissioner Tartaglia and Ken Uhle appeared before the committees to discuss RGP14- Water Bottle Refill Stations. This is a Bond Act in the amount of \$750,000 that will fund the design and installation of fast-fill, bottle fill fountains at various County Parks. First Deputy Commissioner Tartaglia that this would project would replace many of the water fountains in the County Parks system. The purpose of this project is to help visitors go green, reduce liter all while providing a sanitary water option for the public. He said these station are freezer resistant and can be used through the winter months. Mr. Tartaglia discussed that a future project will be spread these stations throughout the County Parks and Trails but this project will replace the fountains only in areas that have existing water line. Mr. Tartaglia said that the bid this out and he will get a better price, but estimating around \$3000 to \$3500 per station. Legislator Walter asked if this project will also allow for water stations to be available indoors? Mr. Tartaglia said, they will look into indoor areas, this is still in the design phase, and they will look anywhere in a park indoor or outdoor to place a refill station.

Assistant Commissioner Zaino of the Planning Department, Commissioner O'Connor & First Deputy Commissioner Tartaglia from the Department of Parks & Recreation appeared before the committees to discuss RBR02-Bronx RIver Reservation- Scout Field.

Commissioner O'Connor began the discussion that there is a lot of interest in Scout Field, and that the Department is still working with the Town of Eastchester. They have done a lot of work to the parks and have a good working relationship with the Town of Eastchester Parks Department. She explained that this projects is to change the scope of work, which Assistant

Commissioner Zaino will discuss.

Mr. Zaino explained that this portion of the project will entail the paving of a currently dirt pathway and rehabilitation to masonry repair to the stairs that currently connect the park to Gramatan Avenue. He explained that they are just adding the funding for this additional work to the project. Mr. Zaino went through the funding and purpose of the current project before the committees.

Chair Tubiolo of the Committee on Parks & Recreation asked that this item be held over so further discussion can be held with the municipalities, committees and Administration. Legislator Woodson- Samuels and Tubiolo are requesting that they have a conversation with all the stakeholders to discuss what has been done and what is going to be done to the Field. Commissioner O'Connor noted the current IMA with the Town of Eastchester has expired and the County has issued a special use permit to the Town of Eastchester until the end of the year. Eastchester and Bronxville maintain the park as set forth in the terms of the IMA. Scout Field is a County Park and the County is responsible for the park.

Chairwoman Borgia of the Budget & Appropriations Committee and Chair Gashi of the Committee on Public Works & Transportation agreed to hold the item for further discussion with all the stakeholders.

Trail in order to retroactively change the commencement date of the IMA from the date of execution, to June 15, 2015. This is necessary to execute payment to the Village in the amount of \$470,000 for the cost of design. The RiverWalk is a 51.5 mile pathway paralleling the Hudson River in Westchester. When completed, it will link village center, historic sites, parks and river access points via a connection of trails, esplanades and boardwalks. The RiverWalk spans 14 municipalities.

The legislation consist of three Acts, a Capital Budget Amendment (CBA), Bond Act and Act (Land Acquisition). The Act is to authorize the purchase and conveyance of approximately 2.4 acres of real property located at 41-51 Maple Street in the Village of Croton to Regan Development Corp. The Bond Act would authorize the County to purchase the property in the amount of \$1,757,576.00 to pay for 29 of the 33 units on the 2.4 acre property. The County would convey the property to the Developer, Regan Development Corp. for \$1.00. The Developer will construct 2 buildings consisting of 42,000 square feet and have 33 residential units with approximately 54 parking spaces. They will include 11 one-bedrooms, 11 two-bedrooms and 11 three-bedroom. 29 of the units will be available to households that earn at or below 30% and up to 80% of the Area median Income (AMI). One unit will be for the superintendent. The development will include a community room, management office and laundry facilities.
