*Mr. Toomey began the conversation by explaining the details of the labor agreement and highlighting important parts of the agreement that were not directly related to the economics being voted on.*

*Ms. Brown added a breakdown of the increases which is a 21.75 % pay increase over eight years. She added, there was an agreement to increase longevity pay, increase in the shift*

*differential, an increase to the County contribution to the welfare fund, and in 2025 there will be a one time equipment allowance.*

*Mr. Toomey clarified, once the equipment amount goes into effect in 2025, it will continue per the Taylor Law along with the welfare fund.*
