INTENT TO BECOME LEAD AGENCY

This notice is issued pursuant to Part 617 of the implementation of regulations pertaining to Article 8 (State
Environmental Quality Review Act) of the Environmental Conservation Law.

The Planning Board of the Village of Tarrytown ("Planning Board") hereby declares its intent to serve as Lead Agency for the proposed application by the Applicant, River Edge Associates LLC ("Applicant"), contract vendee of the property located at 0 Division Street ("Property" or "Site"). The Applicant is seeking site plan approval to amend the Hudson Harbor Project with the final Phase 5 which is proposed to consist of approximately 102,000-sf, 4-story residential building with a total of 81 residential units and 1,500-sf of rooftop amenity space and 157 parking spaces. The site is approximately 2.12 acres and is located in the Waterfront General Business District ("WGBD"). The site is located at 0 Division Street and along Hudson View Way. It is Lot 9 in the Hudson Harbor development. It is currently improved with an unused parking lot, and is labeled as buildings "Q, R and S" in the Amended SEQRA Findings Statement dated June 19, 2006. The Property is part of the previously approved Hudson Harbor development and is the last phase (Phase 5) of that project which has not yet been completed.

The original SEQRA Findings dated February 6, 2006 provided that *"all roadways and sidewalks within the project site must be built to public road and sidewalk standards and dedicated to the Village as public roadways and sidewalks, unless an exemption is granted by the Planning Board during site plan review. **The Applicant will be required to prepare a plan showing the roadways and sidewalks network within the project and their ability to meet these standards for dedication to the Village*** for review and final approval by the Planning Board. The original SEQRA Findings provided for a total of 871 parking spaces, which will not be impacted by the Phase 5 project. The Planning Board will require the specific location of all parking spaces on the Site to be finalized as part of the site plan approval process. The Applicant will cooperate with National Resources (the Master Developer) to close out the Hudson Harbor Project including the use of the Cooney Building and the Open Space Garden on the Cooney lot.

Please be advised that an Environmental Assessment has been prepared and is attached with the proposed amended site plan. The determination made for the proposed action is a Type I action.

If, within 30 days of mailing this notification, no Involved Agency submits a written objection to the Planning Board. The Planning Board said that the Planning Board shall serve as Lead Agency pursuant to 6 N.Y.C.R.R. Part 617.

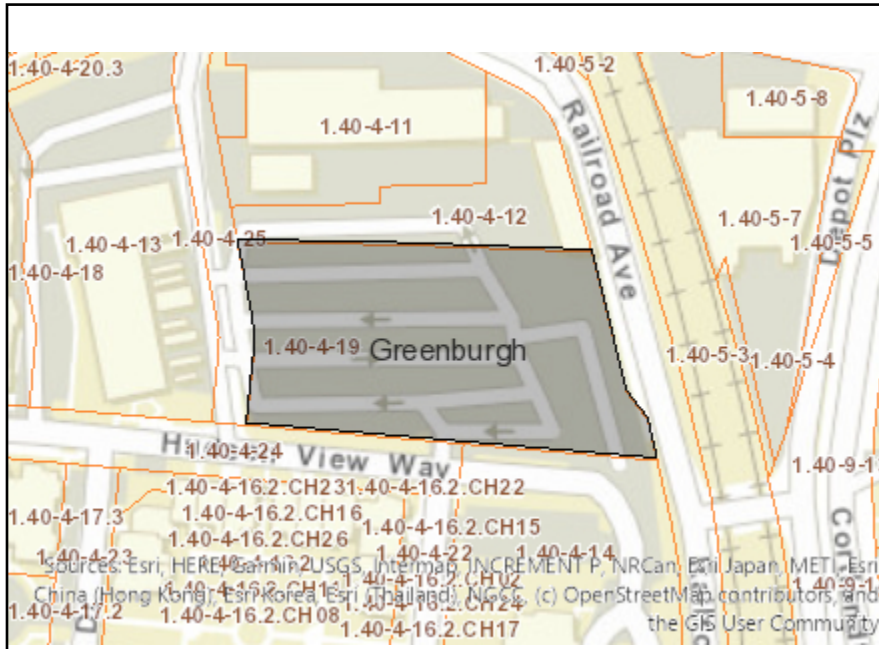
