## ACT 19 - 2024

## BOARD OF LEGISLATORS COUNTY OF WESTCHESTER

Your Committee is in receipt of a proposed Act, which if enacted by your Board, would authorize the settlement of the lawsuit of <u>Jonathan Bocek and Tonya Bocek v. County of</u> <u>Westchester</u>, in the amount of \$175,000.00 inclusive of attorney's fees.

This matter is pending in the Westchester County Supreme Court before the Honorable Damaris E. Torrent. The lawsuit tentatively settled at a settlement conference, pending this Board's approval, in the amount of \$175,000.00, inclusive of attorney's fees.

Rachel Ciccone, Esq. of Kommer Bave & Ciccone LLP, 4 West Red Oak Lane-Suite 102, White Plains, New York 10604, is representing the plaintiffs, Jonathan and Tonya Bocek.

This lawsuit arises out of an incident that occurred at the Kensico Dam Plaza on May 14, 2021. Plaintiff was watching his son's saber light show practice when he felt a pebble in his shoe. He leaned on an electrical control panel and removed the pebble from his shoe. When he placed his foot back on the ground he claims he felt a shock go through the entire right side of his body. He immediately complained of pain and weakness in his right arm and leg. He sought treatment from his primary physician and was diagnosed with arthropathy and neuropathy consistent with electrical injury and was prescribed physical therapy. He treated with a physical therapist for his right side, arm, hand and leg weakness and was thereafter diagnosed with aggravation of degenerative hip osteoarthritis which necessitated a total hip replacement. He claims that he was required to change jobs as a result of his injury.

At trial plaintiff will claim that the County was negligent for failing to properly wire the electrical control panel. He will argue that the County failed to warn him of the danger. The plaintiff will further argue that the County's negligence was the proximate cause of his injuries.

The settlement takes into consideration the uncertainty of litigation and the potential costs of trial, subsequent proceedings and potential appeal. The accompanying Act will authorize settlement of the lawsuit entitled of Jonathan Bocek and Tonya Bocek v County of Westchester, in the amount of \$175,000.00, Westchester County Supreme Court Index No. 67007/2021, inclusive of attorney's fees.

Your Committee has carefully considered the subject matter, the settlement proposal, the attached Act and recommends authorizing the County Attorney or his designee to settle the lawsuit entitled Jonathan Bocek and Tonya Bocek v County of Westchester et al., in the amount of \$175,000.00, Westchester County Supreme Court Index No. 67007/2021, inclusive of attorney's fees.

An affirmative vote of a majority of the Board is required to pass this legislation.

## ACT NO. 19 - 2024

AN ACT authorizing the County Attorney to settle the lawsuit of John Bocek and Tonya Bocek v <u>County of Westchester</u>, Westchester County Supreme Court Index No. 67007/2021, in the amount of \$175,000.00, inclusive of attorney's fees

BE IT ENACTED by the Board of Legislators of the County of Westchester as follows:

Section 1. The County Attorney is authorized to settle the lawsuit of Jonathan Bocek

and Tonya Bocek v. County of Westchester, Westchester County Supreme Court Index No.

67007/2021, in the amount of \$175,000.00, inclusive of attorney's fees.

Section 2. The County Attorney or his designee is hereby authorized and empowered to execute and deliver all documents and take such actions as the County Attorney deems necessary or desirable to accomplish the purpose of this Act.

Section 3. This Act shall take effect immediately.
