# I. ITEMS FOR DISCUSSION

Presentation by Environmental Leaders of Color

#### Guest:

Marvin Church, Founder & Acting Associate Director - Environmental Leaders of Color Chair Woodson-Samuels provided an overview on the topic and invited the guests to introduce themselves. Mr. Church provided an overview on the Environmental Leaders of Color (ELOC) 2023 Student Summer Energy & Environmental Program for Teens. Afterwards the winners of this program presented their final project on proper ways to dispose of cooking oils. Throwing cooking oil in the drains will eventually solidify which leads to clogging of drains and subsequently cause flooding, buildup of mold and mildew and compromise building structures. ELOC will be starting a public awareness campaign to come up with actionable steps on how to properly dispose of cooking oil. Additionally, they recommended that people collect their used cooking oil and drop it off at the Westchester County Household Material Recovery Facility in Valhalla.
