*Guests from the Department of Corrections explained, this is a project that has been studied and is part of a larger program. The body alarm system has been in use for approximately 30 years and has reached the end of its useful life as there are no more upgradeable features to*

*it. Along with it, the camera system is in the same situation. These small parts are part of a larger project for security upgrades and the department would like to accelerate this part of the project. They described the phone and cameras systems and how they work in tandem with one another. The systems are very important to the life safety of the staff.*

*Legislator Clements asked how long it will take to get the new systems in place. The guests responded that while there is no definitive timeline they are estimating 6-9 months.*

*The guests also expressed there will be over 1400 cameras replaced, the 6-9 months timeline accounts for delays and there will be significant resolution increases along with enhanced features for optimal use.*

*There were some questions regarding the process, procedures and pay for instructors that this IMA includes which was cleared up by the guest. He explained, this is template to be used and entered into agreement with individual participating agency and there is no cost to County for the instructors or the officers using the range.*

*Legislator Clements asked if there is any financial consideration given to the wear and tear to the range caused by the extended use by other municipalities. The guest answered, the wear and tear is so minimal that he doesn't believe it is worth quantifying or trying to recoup.*
