He oversees AAF's policy research work that highlights the accomplishments and the needs of the diverse range of Asian American communities in the New York City metro area. Howard has authored or co-authored reports on Asian Americans, covering topics such as economic contributions, poverty, seniors, mental health and children's issues. Among the most recent report were The Impact of COVID-19 on Asian American Employment in New York City (2021), Hidden in Plain Sight: Asian Poverty in New York City (2018), NYC's Economic Engine: Contributions & Challenges of Asian Small Businesses (2016), and Analysis of City Government Funding on Social Service Organizations Serving the Asian American Community in New York City (2015). Mr. Shih has also been published two articles in UCLA's AAPI Nexus Journal.
