Chief Sandra DiRuzza-Bio

Chief DiRuzza began her law enforcement career as a Police Officer in January of 2004. In September of 2005, then Officer DiRuzza, became the department's first female DARE Officer. She attended DARE training in Nashua, New Hampshire and taught the DARE program at the Rye Neck Middle School, Mamaroneck Avenue School and the Westchester Day School from January 2006 until May 2011. In 2007, DiRuzza implemented the department's Domestic Violence Unit. The DV Unit was created to provide victims of domestic violence with services and resources. In May of 2009, then Officer DiRuzza, was appointed to the position of Detective. She received additional training in domestic violence services as well as youth services and became certified as a Juvenile Officer. In this dual role, Detective DiRuzza investigated cases of domestic violence as well as juvenile cases. In 2009, Detective DiRuzza began assisting the Westchester County Police Academy (WCPA) with their instruction of domestic violence to new recruits. She continues to assist the WCPA in this capacity. In 2010, Detective DiRuzza was appointed as the department's Public Information Officer. In January of 2015, DiRuzza was promoted to the rank of Sergeant. In her role as Sergeant, she was responsible for the training, directing, and supervising of personnel in their assigned duties. In May of 2018, Sgt. DiRuzza was promoted to the rank of Lieutenant. In her role as Lieutenant, DiRuzza was responsible for the day-to-day operations of the Patrol Division (now the Community Services Division). She also worked with the Traffic Commission and participated in walking safety assessments to identify areas of concern involving both pedestrians and motorists. Lieutenant DiRuzza was also responsible for the oversight and implementation of the yearly Governors Traffic Safety PTS grant for the department. This grant promotes increased enforcement of safety initiatives such as the "Click It or Ticket" and "No Empty Chair" campaigns. In December of 2020, Lt. DiRuzza was named provisional Police Chief of the Village of Mamaroneck Police Department. In March of 2021, she participated in and passed the Police Chief's Exam. She became the official Village of Mamaroneck Chief of Police in September of 2021.

Faheem Jamal is resident of Westchester County with a degree in business administration from Pace University, with a major in management and a minor in economics. Faheem began stocking shelves for Chestnut Marts at 14 years old. Since then, he has risen in the ranks to becoming the director of convenience store operations for CPD and its 60 locations across the Tri-State area, 26 of which are in Westchester County, now under the name Chestnut Market.

After working as a stock person, Faheem began training as a sales associate. After demonstrating above-average sales skills as a cashier, Faheem was asked to serve as interim manager at a location that had been struggling, just months after being moved to cashier.
