Ms. Lopane discussed the item with the committee. She said that the Amended Bond Act, in the total amount of \$1,800,000, which includes \$1,000,000 in previously authorized bonds of the County, would finance the cost of design, construction management and construction of signage and wayfinding improvements at the County's Valhalla Complex. Legislator Pierce asked why the cost had increased by \$800,000. Ms. Lopane said that the project now included Phase 2 as well as Phase 1. Legislator Pierce noted that the Committee Report and Capital Project Fact Sheet provided that the additional funds are needed due to inflation. Legislator Pierce requested that the Committee Report and Capital Project Fact sheet be amended to provide that "Additional funds are needed for the signage fabrication and installation due to inflation as well as to combine the previously proposed two phases of the project into one single phase."

6. 2023-489 ACT - Compromise of Claim - "B.J."

AN ACT authorizing the County of Westchester to compromise its right to be reimbursed for health care and wage benefits paid to or on behalf of a County employee "B.J." from a settlement of his legal action against a third-party tortfeasor.

Associate County Attorney Sean Carey explained that on October 22, 2018, B.J., an electrician in the County's Department of Environmental Facilities, tripped and fell on

construction materials that were left out in the North Yonkers Pump Station's maintenance room by a County vendor. When he fell, he was carrying a 100-pound auxiliary-generator battery, which fell on his shin and injured his right ankle, shin, and arm. He underwent surgery and missed 41 weeks of work.

Mr. Carey said that B.J. filed a Workers' Compensation claim and brought a personal-injury action against the County vendor. On October 5, 2023, B.J. agreed to settle his personal-injury action for \$215,000, pending the County's consent. B.J. had attorney's fees of \$71,666.67 and costs and disbursements of \$5,582.70, for a total litigation cost of \$77,249.37.

Mr. Carey stated that between the date of the accident and the proposed settlement, the County expended medical benefits of \$14,111.59 and indemnity (lost wage) benefits of \$36,803.65, for a total of \$50,915.24. The County Attorney wants to compromise the County's claim for reimbursement by reducing its lien by 35.93% (\$18,293.85), and accept \$32,621.39 in satisfaction of its present lien. After the County is reimbursed and counsel fees are paid, B.J. would receive \$105,129.24.

County Attorney John Nonna said that this would authorize the County to enter into an agreement to retain the law firm of Jackson Lewis to provide counsel to the County on the issue of multi-employer pension plan withdrawal liability. He noted that he would be dealing with one partner of the firm, Keith Dropkin, who has specialized expertise on this complicated issue, and provided counsel on this to the County ten or eleven years ago. He also noted that very few firms or lawyers have expertise in this area.

Legislator Barr asked if we can provide in the contract that we are retaining only Mr. Dropkin for advice on this one specific issue. Mr. Nonna said he can add language clarifying that to the contract.

Legislator Nolan asked whether the union has brought up any concerns about the County dealing with this firm. Mr. Nonna said they have not yet told either side who our law firm is.

With a motion by Legislator Imamura seconded by Legislator Barr, the committee went into executive session at 12:47 p.m. to discuss legal matters and legal advice. With a motion by Legislator Imamura seconded by Legislator Parker, the committee came out of executive session at 1:15 p.m.

County Attorney Nonna said he would clarify the proposed contract and research other possible of-counsel lawyers prior to the next meeting.
