Legislator Clements asked what the \$1,000,000 will be specifically used for. The guests explained this \$1,000,000 in bonding will be for the first phase of design testing which includes putting the system in and testing of the new equipment. Subsequently a bond request

will be coming down for the actual construction of the project.
