WHEREAS, in accordance with SEQRA and its implementing regulations, a Short Environmental Assessment Form has been prepared to assist this Honorable Board in its environmental assessment of this proposed action; and

WHEREAS, this Honorable Board has carefully considered the proposed action and has reviewed the attached Short Environmental Assessment Form and the criteria set forth in Section 617.7 of the implementing regulations and has identified the relevant areas of environmental concern, as described in the attached Short Environmental Assessment Form, to determine if this proposed action will have a significant adverse impact on the environment.

NOW, THEREFORE, be it resolved by the County Board of Legislators of the County of Westchester, State of New York, as follows:



The subject property is currently served by an onsite subsurface treatment system that is subject to repeated failure.

The proposed Town sewer extension requires an act of the County Board of Legislators in order to modify the Peekskill Sanitary Sewer District to include the subject parcel within the County sewer district. For the reasons set forth in the Town's Short and Full Environmental Assessment Forms (attached), the pump station and sewer lines proposed by the Town to convey sewage from the subject property to existing sewer infrastructure located near Ridge Road are not anticipated to have a significant impact on the environment as they will be located within existing disturbed areas. The proposed pump station will be situated on a cleared lawn area of the subject property adjacent to Furnace Woods Road, and the sewer lines will be installed within the roadbed of the aforementioned local roads. The Town is expected to comply with applicable NYSDEC regulations to ensure that construction impacts do not affect any nearby wetlands.

Sewage from the Peekskill Sanitary Sewer District is conveyed to the Peekskill Water Resource Recovery Facility for treatment prior to discharging into the Hudson River. The facility has a design flow of 10 million gallons per day (MGD) and the average daily flow is 6.1 MGD. The average daily flow from the property is currently approximately 16,000 gallons per day. As such, the existing county sewer infrastructure has sufficient capacity to accommodate the additional sewage from this parcel.

The proposed sewer connection will serve to protect the environment by preventing potential health hazards and environmental contamination associated with failing septics.



The proposed action would result in the construction of 7,000 linear feet of sewer main and a sewage pump station. The proposed sewer main would be constructed entirely within an existing, previously disturbed road bed and would not be expected to result in any new land disturbance. Any land disturbance related to the construction of the sewer main would be temporary and limited to a 4.5 foot trench within the route of the sewer main. The sewer main route would follow Lafayette Avenue south from Ridge Road to Maple Avenue and Furnace Wood Road where it would terminate at the Yeshiva Ohr Hameir Campus near the site of the proposed pump station. The proposed sewer pump station would be constructed within an approxiamlely 4,000 sf existing lawn area on the existing Yeshiva Ohr Hameir school campus and would not result in any disturbance to wellands or waterbodies or significant wildlife habitats. Therefore, the proposed action would not be expected to result in any significant adverse environmental impacts.
