## MINUTES APPROVAL

## I. ITEMS FOR DISCUSSION

1. <u>RES-2022-199</u> <u>PH - Prohibiting the Sale or Distribution of Flavored Tobacco</u> Products

A Public Hearing on "A LOCAL LAW adding a new Chapter 539 of the Laws of Westchester County in relation to prohibiting the sale or distribution of flavored tobacco products." [Public Hearing set for November 14, 2022 at 7:30 p.m.]. LOCAL LAW INTRO: 2022-461.

Chair Smith and Legislator Williams Johnson introduced the guests and invited Mr. Chen to share what changes were made to the legislation. Mr. Chen outlined the following changes which began with the removal of the reverse preemption clause, adding a clause specifying that nothing in this law intends to conflict with Section 1399 E of the New York State Public Health Law, specifying that the Westchester County Department of Health is the sole enforcing agency, the pushing out the effective date to 3-6 months, clarifying that establishments are the intended target of the law, not individuals, nor is user possession meant to be targeted. Mr. Chen confirmed that there are no criminal penalties with this law in response to Chair Smith's question.

Legislator Williams Johnson expressed remarks as to why this legislation would be beneficial to pass in the County and where to find recordings from previous meetings on the topic. She provided statistics and the effects that smoking has had on different communities and youths in general. Additionally, she expressed how tobacco companies have used mentholated tobacco products as a way to entice people into consuming their products.

Deputy Commissioner (DC) Ericson asked if pipe tobacco was included and a discussion ensued to decide whether or not this legislation should explicitly state "pipe tobacco" within it. He also provided insight on distribution and asked if it includes mail order. Legislator Williams Johnson confirmed that it cannot be on the property either and Legislator Barr explained how this change came to fruition. DC Ericson also added that additional staff may need to be hired to fulfill their responsibilities under this law.

Legislator Pierce motioned to amend the law to include "pipe tobacco" in Section 539.01 Subsection 7 of the Local Law, it was seconded by Legislator Barr and unanimously approved.

On motion of Legislator Maher, seconded by Legislator Barr, the above item was signed by committee and referred to Board of Legislators, due back on 10/17/2022. The motion carried by the following vote:
