Chair Williams Johnson invited all guests to introduce themselves and for Dr. Milovanovic to share why this topic came up during the previous budget season. After Dr. Amler's introduction, Dr. Canter began her presentation on the topic. She began by explaining safe sleeping practices for babies, initiatives throughout Westchester and some of the reasons why parents make sleeping accommodation mistakes with their children. Dr. Canter's presentation also included an explanation on the changes in terminology, available educational programs in the County and recommendations on how this mishap can be avoided for parents. Dr. Amler added that SIDS still exists in response to Legislator Barr's questions and Dr. Canter provided more details as to how this terminology comes into the fold when determining why the child has died. Dr. Milovanovic's presentation included proper safety practices and what to avoid when placing a baby in their sleeping area. Deputy Commissioner Hinds spoke about the programs available to the public that are provided by the Department of Social Services as well as their community partners. Ms. Seelig detailed how the caseworkers onboard in the department to receive trainings regarding the Safe Sleep program and their pack-n-play distribution program.

Chair Williams Johnson thanked the guests and proceeded to conclude the meeting.
