He said that most of the requested \$1.5 million in additional funding is due to a shortfall from the municipality's failure to receive an expected \$900,000 DOT grant. Chair Gashi said the committee report does not include that information and needs to be amended. Legislator Pierce asked for a cost breakdown for the revised cost. Mr. Kvinge said there are hundreds of invoices, some of which he has not received yet. They have processed \$3 million in invoices and are expecting another \$1.5 million. He said the project is completed, but they are catching up with paperwork. He said he has the estimate from the engineer, which he will provide. Legislator Maher noted that there should be a completed punchlist, monthly, quarterly, and final requisitions, or other backup. Chair Gashi asked if someone from the municipality had that information, and Mr. Kvinge said he only received the project engineer's estimate.*
