I. ITEMS FOR DISCUSSION

RES-2023-8 2023 Joint State Legislative Package

A Resolution forwarding the Westchester County 2023 Joint State Legislative Package to the County's State Delegation for consideration during the current legislative session.

SUBMITTED BY: THE COMMITTEE ON LEGISLATION

Chair Smith spoke about the changes to the Joint State Legislative Package that were made since the previous meeting. He indicated that one item was added as a budgetary priority,

three items were added to the State Delegation Support List, and one item was removed from the package. He began by speaking on the adds to the State Delegation support list regarding increased tax exemptions for two veterans living in the same household, the issuance of points on an individual's license for drag racing, and support for the All-Electric Building Act. Legislator Cunzio asked if there were any requirements regarding the marital status of the veterans and it was confirmed there were not provided they both lived at the same address. He then spoke briefly on the item removed regarding Accessory Dwelling Units and noted that legislation for the 23-24 session has not yet been introduced. Finally, he spoke on the addition to the budgetary initiatives, related to indemnification for ad litem attorneys. After discussion on the actual purpose of the initiative was, Legislator Barr requested the description be changed to correctly indicate the intent. Legislator Barr asked what determined if something was a legislative priority or an item for the State Delegation Support List and Mr. Figueroa said that legislative priorities are higher ranked items that directly impact Westchester, while items for the State Delegation Support list are bills members of the State Delegation have requested specific support on.

On motion of Legislator Barr, seconded by Legislator Boykin, the above item was signed by committee and referred to Board of Legislators. The motion carried by the following vote:
