Legislator Pierce began by discussing the changes to the law, which largely covered the inclusion of the County's Department of Environmental Facilities (DEF) as an enforcing Agent for retail food establishments, healthcare facilities, and schools. Ms. Macleod, further explained the specific changes, and noted that these changes were the result of feedback from various departments and legislators. Legislator Cunzio asked if DEF has enough staff to undertake this role and Ms. Macleod confirmed that they indicated they do. Legislator Cunzio requested a cross reference between items in the definitions and exemptions section, which Legislator Boykin confirmed has been done in the past, for clarity. Legislator Boykin expressed concerns about our law being preempted by NYS and Ms. Macleod explained that this is something they have considered and were confident wouldn't be an issue. Legislator Nolan asked how this would affect mobile entities like food trucks and Legislator Pierce said that, in her experience, food trucks usually ask customers what they want before providing it.

Ms. Macleod explained the change to the restrictions section, the most significant being the addition of retail food store, and Legislator Cunzio asked if the capability for additional exemptions was present in the legislation, in the event of another pandemic, and Ms. Macleod confirmed it was. Legislator Boykin asked about defining elderly and it was agreed that simply changing it to programs that deliver meals would be sufficient. Legislator Barr thanked Ms. Macleod and the department for their efforts and looked forward to the new changes, and highlighted the six-month non-enforcement period, followed by an additional six months before fines would start being levied. Legislator Nolan asked about making people aware about the law, and Legislator Barr explained that it would be a collaborative effort.

On motion of Legislator Maher, seconded by Legislator Boykin, the above item was signed by committee and referred to Board of Legislators. The motion carried by the following vote:
