# I. ITEMS FOR DISCUSSION

1. 2023-106 PH-County's Human Rights Law and Fair Housing Law

Joint with Human Services, Human Rights & Equity and Housing committees. Guests: Human Rights Commission: Tejash Sanchala, Executive Director, and Joshua Levin, Fair Housing Director; Law Dept.: Chief Deputy County Attorney Stacey Dolgin-Kmetz

Mr. Sanchala discussed changes he had made to the law. He said that the state human rights law was amended to broaden the definition of a domestic employee, so we just tracked that definition for the County law. The word "intern" was moved from non-employee to employee. Also, the military status definition did not include reserve, so that was changed.

He also added the language for harassment under the New York state standard to the County law.

He added the words "reasonable accommodation for pregnancy related conditions."

He noted that the liberal construction paragraph expressly provides that if there is any conflict between paragraphs in the law, the liberal construction should control.

He said that the fair housing law had to be amended because it provided that the matter shall be exclusive, but the federal fair housing law allows you to file a case in court and file a case with the County Human Rights Commission as well, so they removed the exclusivity provision.

Legislator Imamura noted that New York City recently added to their human rights law to include discrimination based on weight, and asked if we should we consider that here. Mr. Sanchala said that since that just happened on Thursday, and he hasn't had a chance to study the new law, it would be premature for him to comment. It would also need to be discussed by the County's Human Rights Legislation committee.
